<p><b>Criterion 40a:</b> CDID provides emerging solutions to Future Forces Integration Directorate (FFID) for CP consideration Quarterly.</p> <p>Note: Quarterly input allows proponents to introduce emerging solutions to immediate needs or emerging extremely high risk capability gaps outside of the annual CNA cycle.</p>	<p><b>40a(1):</b> CDID provides significant majority of solutions to CNA rather than as quarterly inputs to FFID.  <b>Rationale:</b> The CNA is the basis of CP Development. The intent of quarterly input is to allow CDIDs to provide emerging solutions for consideration, not as a means to bypass CNA.</p>	TRADOC PLANORD 09-0001.	List of submissions	X				
	<p><b>40a(2):</b> CDID maps quarterly solution submissions to gaps according to the current CNA Gap list.  <b>Rationale:</b> This task is normally conducted during CNA; CDID needs to conduct it for emerging solutions so as to avoid delays.</p>	TRADOC PLANORD 09-0001.		X				
	<p><b>40a(3):</b> CDID ensures quarterly submitted solutions meet at least 2 of 3 evaluation criteria.  <b>40a(3)a:</b> Does solution mitigate an extremely high risk gap?  <b>40a(3)b:</b> Does solution mitigate multiple gaps?  <b>40a(3)c:</b> Does solution mitigate gaps for multiple formations?  <b>Rationale:</b> These evaluation criteria are used by FFID to separate CNA solutions into those considered for Capability Packages and those which continue under the proponents' modernization strategies.</p>	TRADOC Reg 71-20. 	<p><b>40a(4):</b> CDID includes DOTMLPF readiness statuses for quarterly solution submissions. (i.e. Technology Readiness Levels, Basis of Issue, current cost, Training Support Packages, etc.).  <b>Rationale:</b> Allows FFID to immediately bucket solutions into appropriate Capability Packages without delays for research.</p>	TRADOC PLANORD 09-0001. <p><b>Criterion 40b:</b> CDID participates in CP governance.  Note: FFID requires regular proponent input to produce Capability Packages that meet Army needs</p>	<p><b>40b(1):</b> CDID participates in bi-weekly BDE Modernization and Integration VTCs.  <b>Rationale:</b> CDIDs who do not participate do not have opportunity to vote on Capability Packages.</p>	TRADOC PLANORD 09-0001. 	<p><b>40b(2):</b> CDID participates in Quarterly CIEFs. (Mandatory).  <b>Rationale:</b> CDIDs provide updates on CP Solution Statuses.
