SUBJECT: Garrison Policy 31, Environmental Quality Control Committee (EQCC)

1. Reference. AR 200-1, (Environmental Protection and Enhancement)
2. Purpose. The purpose of this policy is to establish the Fort Leonard Wood (FLW) Environmental Quality Control Committee (EQCC). The EQCC helps plan, execute, and monitor actions and programs with environmental implications and provides a forum for environmental management reviews. The committee advises the Garrison Commander on matters of an environmental nature.
3. Membership. The Chairperson of the EQCC shall be the Garrison Commander and the membership will consist of personnel representing the operational, logistics, engineering, planning, resource management, legal, medical, environmental, morale, welfare, and recreation (MWR), commissary, exchange service, and safety interests of the command, including military installation tenant activities. The members of the FLW EQCC are listed at Enclosure 1. The organizations/personnel listed may designate an alternate member, if necessary.
4. Schedule. The FLW EQCC will meet quarterly or more frequently, if needed. The EQCC chairperson may call unscheduled meetings for specific purposes. Otherwise, the Directorate of Public Works, Environmental Division will establish meeting dates, develop agendas, and distribute minutes.
