

Macedonia Pond

Impoundment Rules and Regulations

Macedonia Pond is located within Hunting Area 18, **access is controlled by Hunting Area Status.**

Any person wishing to fish at Macedonia Pond must first check the daily Open Hunting Area Announcement by calling 573-596-4224.

If the Hunting Area is open, a person must physically check in at Range Control (Bldg 5282) or by email through the FLW Hunting and Fishing website <http://www.wood.army.mil/dptm/handf.htm> and be issued a Hunting Area Access Pass. Registration must be completed on the same day access is desired.

A Missouri Fishing Permit is required except for Missouri residents who are sixty-five (65) years of age or older, and any person who is fifteen (15) years of age or younger. A Missouri Fishing Permit may be purchased online at: <https://mdc.mo.gov/>

A Fort Leonard Wood Sportsman's Permit is required and can be purchased through the Outdoor Adventure Center (<http://www.fortleonardwoodmwr.com/outdoor.php>). Missouri residents who are sixty-five (65) years of age or older, and any person who is fifteen (15) years of age or younger will receive one (1) Sportsman's Permit free of charge at the Outdoor Adventure Center.

Vehicle use is restricted to graveled and paved roads and parking areas only.

Boats are allowed (no gasoline-powered motors may be used).

A person may use no more than three (3) poles at any time, and the poles must be attended at all times.

Bullfrogs and green frogs may be taken during the statewide season only by hand, hand net, gig, snagging, snaring, grabbing, or pole and line.

Netting or trapping of live bait is prohibited.

Fishing is prohibited where designated by signs.

Daily catch limits:

- Frogs - **eight (8)**
- Black bass - **four (4)** IMPORTANT: Black bass more than twelve inches (12") but less than fifteen inches (15") total length *must be returned to the water immediately after being caught!*
- Channel catfish of any size - **four (4)**
- Crappie of any size - **thirty (30)**
- Fish of any size (other than black bass, channel catfish, and crappie) - **twenty (20)**

Posted regulations are IAW Fort Leonard Wood regulation 210-21-5a-f and the Missouri Wildlife Code.

Macedonia Pond

Driving directions to Macedonia Pond from The Outdoor Adventure Center, FLW K, (573)-596-4223.

1. Travel west on FLW K to FLW 10 for 0.5 miles and turn right.
2. Continue on FLW 10 for 692 feet to Minnesota Ave and turn left.
3. Continue on Minnesota Ave for 1.1 miles to Nebraska Ave and turn Left.
4. Continue on Nebraska Ave for 2 miles to Iowa Ave/FLW 1 and turn left.
5. Continue on FLW 1 for 8.5 miles to State Highway AW.
6. Continue on State Highway AW for 3.3 miles to State Highway 17 and turn right.
7. Continue on State Highway 17 for 8.6 miles to Macedonia Cemetery Rd. and turn right.
8. Continue on Macedonia Cemetery Rd for 1.0 miles to FLW U and turn left.
9. Continue on FLW U for 0.9 miles to MT 009 and turn left.
10. Continue on MT 009 for 0.3 miles and pond entrance will be on your left.
